The Medicine – General Rules pertain to definitions, prescribing of drugs by physician's assistants, delegation of prescribing controlled substances to advanced practice registered nurses, training in identifying human trafficking, medical education accreditation standards, licensure, foreign-trained licensure, licensure by endorsement, educational limited licenses, examination, clinical academic licenses, relicensure, license renewal, and continuing education.

Amendment of the rules will take place to supply revisions of definitions, rescind an English language requirement, rescind a display name requirement, include a rule on telehealth, revise prescribing of physician's assistants requirements and delegation of prescribing to advanced practice registered nurses requirements, clarify dates for human trafficking training, update accreditation standards, and revise licensure, foreign-trained licensure, licensure by endorsement, educational limited licensure, examination, clinical academic licensure, relicensure, renewals, and continuing education requirements.
