The Department of Licensing and Regulatory Affairs will hold a public hearing to receive public comments on proposed changes to the Public Health Code--General Rules rule set.

The proposed rules will add definitions for terms used in the rules; add midwifery to the biennial renewals; add quadrennial license renewals for behavior analysts; change the renewal date for optometry, pharmacy, physician's assistants, dentistry, medicine, osteopathic medicine and surgery, podiatric medicine and surgery, and veterinary medicine to the date when the initial license was issued; and add the department's minimum English language standard for licensure or registration.

MCL 333.16145, MCL 333.16194, MCL 333.16201, MCL 333.16221, MCL 338.3501, MCL 445.2001, MCL 445.2011, and MCL 445.2030. These rules will take effect Immediately after filing with the Secretary of State.
