## 7. Describe the general purpose of these rules, including any problems the changes are intended to address.

GI Part 62 Plastic Molding gives direction to employers and employees on protecting Michigan employees from health and safety hazards in the workplace when using plastic molding machines. The standard is being amended for lockout and guarding to reflect current technologies used in the industry and to review for clarity and consistency.
