1 Wednesday, May 24, 2023

2 At or about 1:30 p.m.

3 MR. NOLISH: Okay. We are opening the  
4 Public Hearing on the Health Care Services Rules.  
5 Today is May 24th, 2023. This hearing was  
6 scheduled for 1:30 p.m. It is now 1:35 p.m. We  
7 have no signed-in guests appearing here today. My  
8 name is Jack Nolish. I'm Director of the Workers'  
9 Disability Compensation Agency and I will be  
10 facilitating the hearing today.

11 For the record, this is a public  
12 hearing on proposed administrative rules entitled,  
13 "Department of Labor and Economic Opportunity,  
14 Workers' Disability Compensation Agency  
15 Administrative Rules for Workers' Compensation  
16 Health Care Services, also known as HCS." This  
17 hearing is being conducted pursuant to provisions  
18 of Sections 205 and 315 of the Worker's Disability  
19 Compensation Act of 1969, Public Act 1969 Number  
20 317, also know as MCL 408.205 and 418.315, Section  
21 33 of the Administrative Procedures Act of 1969  
22 which is 1969 PA 306, MCL 24.233, and Executive  
23 Reorganization Order Numbers 1982-2, 1986-3,  
24 1990-1, 1996-2, 2003-1, 2011-4, and 2019-13, also  
25 identified as MCL 18.24, 418.1, 418.2, 445.2001,

1 445.2011, 445.2030, and 125.1998.

2 This hearing, as I said previously, was  
3 called to order at 1:36 at the Worker's Disability  
4 Compensation Agency Claims Conference Room 2501  
5 Woodlake Circle, Okemos, Michigan. This hearing  
6 was appropriately published in three newspapers of  
7 general circulation, as well as the Michigan  
8 Register, Issue #7-2023, published on May 1st of  
9 2023.

10 For the record, we are here today to  
11 receive comments on the proposed rules. Anyone  
12 wishing to speak, please make sure you've signed  
13 in and indicated your willingness to speak. We  
14 will call on speakers in the order in which names  
15 are listed on the sign-in sheet. When you come  
16 forward to speak, please identify yourself with  
17 your name, the organization you represent, and  
18 both your mailing and email address so that this  
19 information may be transcribed into the hearing  
20 report. Pursuant to Attorney General Opinion  
21 #5183, issued March 8th, 1977, we will limit the  
22 time for each presentation to ten minutes. If you  
23 have additional comments to submit in writing, you  
24 may leave them at the registration desk or submit  
25 them to our Department no later than 5:00 today

1 Eastern Daylight Time.

2 Are there anyone here -- anyone here  
3 present interested in speaking or presenting any  
4 information? For the record, prior to the  
5 commencement of this hearing we have received five  
6 written communications, one from OPTUM, O-P-T-U-M,  
7 dated May 24th, 2023 signed by Adam Fowler,  
8 Manager of Public Policy & Regulatory Affairs.  
9 The second is from AAPAN dated also May 24th, 2023  
10 signed by Julian Roberts, President and CEO  
11 American Association of Payers, Administrators and  
12 Networks using the initials AAPAN. The next is  
13 from the HealtheSystems dated May 19th, 2023  
14 signed by Tiffany Grzybowski, Analyst, Advocacy  
15 and Compliance from HealtheSystems. Next from  
16 APTA, American Physical Therapy Association, a  
17 letter dated May 24th signed by Edward Mathis, PT,  
18 DPT, the president of the organization. And last  
19 but not least, APTQI, the Alliance for Physical  
20 Therapy, Quality and Innovation, dated May 24th,  
21 2020, three signed by Nikesh Patel, PT, DPT.  
22 These letters are both some are in support, some  
23 are in opposition.

24 It is now 1:40. We'll keep the record  
25 open for an additional five minutes to see if

1 anyone wishes to appear and testify. So, we are  
2 adjourned until then.

3 (Whereupon a brief pause was  
4 Held in the proceeding)

5 MR. NOLISH: We're back on the record  
6 in the Public Hearing regarding the Health Care  
7 Services Rules. It is now 1:46 p.m. No one has  
8 come forward to testify or present any other  
9 documentation. We are, therefore, going to close  
10 the hearing at this time. If anyone is interested
