3 MR. WILLIAMSON: Good afternoon. My name is Tony 4 Williamson. I am a Departmental Analyst for the Bureau of 5 Construction Codes and the Department of Licensing and Regulatory Affairs, and I will be conducting the hearing 6 7 This is a public hearing on proposed administrative today. 8 ruled entitled "Part 9A Mechanical Code-Rule Set 2022-55." 9 We are conducting this hearing under the authority of the 10 Administrative Procedure Act, Public Act 306 of 1969 on 11 behalf of the Department of Licensing and Regulatory 12 Affairs, Bureau of Construction Codes.

13 We are calling this hearing to order at 1:07 p.m. 14 on August 22nd, 2023, at the Michigan Library & Historical 15 Center, First Floor Forum, 702 West Kalamazoo Street, in 16 Lansing, Michigan 48915. Publication of the notice of 17 public hearing was in the Morning Sun and the Oakland Press 18 on July 27th, 2023, and the Mining Journal on July 28, 2023. 19 These papers are newspapers of general circulation. The 20 notices were also published in the Michigan Register, Issue 21 number 14-2023, on August 15, 2023.



MR. DEARY: Thank you, Mr. Williamson. Thank you, Mr. Williamson and members of the board. My name's Thomas Deary. That's D-e-a-r-y. I'm with The Air-Conditioning, Heating, and Refrigeration Institute. Thank you for having us today. I'd like to propose the following amendment regarding the section 1101 or the 2021 International Mechanical Code, specifically 1101.1.1, Refrigerants Other Than Ammonia. We propose adding the following sentence at the end of paragraph one. And that sentence reads: "Assistance using A2L refrigerants shall comply with ASHRAE 15."

14 Supporting that, in chapter 15 of standards, we 15 propose updating the following standards, ASHRAE 15, Safety 16 Standard for Refrigeration Systems, and ASHRAE 34 17 Designation and Safety Classification for Refrigerants, both 18 to the 2022 edition, and also ULCSA 6335-2-40, Household and 19 Similar Electrical Appliances Safety, Part 240, Particular 20 Requirements for Electrical Heat Pumps, Air Conditioners, 21 and Dehumidifiers. And ULCSA 6335-2-89, Household and 22 Similar Electrical Appliances Safety, Part 2-89, Particular 23 Requirements for Commercial Refrigerating Appliances Within Incorporated or Remote Refrigerant Due to the Compressor. 24 25





current editions, -2-40, the 2022 edition, and -2-89, the 2021 edition.

And our substantiation for those changes is that manufacturers are transitioning away from UL 1995 to UL 6335-2-40 for new products because UL 1995 will be withdrawn by UL effective 1-1-2024. The newest fourth edition of UL 6335-2-40 published in December of 2022 has many new requirements for electrical and refrigerant safety certification, and laboratories will use the latest version of the UL 6335-2-40 Safety Standard for Certification Testing.

With the change to low-gwp refrigerants the 12 13 mechanical code needs to be updated to be updated to address 14 the use of low-qwp refrigerants in high probability systems. 15 All of these commonly used low-qwp refrigerants fall 16 directly in the category between group A2L and 2022 edition 17 of ASHRAE 34 and ASHRAE 15. As such, reference to the 2021 18 edition of this standard is also included in this proposal 19 as approved by the ICC for the forthcoming 2024 IMC. Thank 20 you.

3	I'm just here today to continue to support our written
4	comment, especially on the following in regards to the 2021
5	International Mechanical Code, Section 603.9, and accepting
6	the new exemption, Section 1102.3, deletion of Access Port
7	Protection, and Section 1101.9, deletion of Blocking Access
8	Port Caps.
9	So we have submitted everything. I just wanted to
10	thank you for your consideration and allowing us the
11	opportunity to comment on that. That's all I have today.

14	BY WILLIAM HORDYK:
15	MR. HORDYK: Hello. My name is William (Bill)
16	Hordyk, H-o-r-d-y-k. I'm a registered building official in
17	the State of Michigan, serving the community of Grand
18	Rapids. I also have 20 national certifications and the
19	International Code Council, including master code
20	professional. I come to you duly elected by the Metro
21	Building Inspectors Association of Greater Grand Rapids to
22	speak on their behalf regarding these matters. The Metro
23	Building Association is a group of 130 registered building
24	officials and inspectors performing their duties for over 70
25	different delegating authorities in the State of Michigan.



1 I'm starting with rule 901a. The strike and bold 2 text of rule 901a is incorrect. It does not include all the 3 text from the current rule as written in Michigan 4 Administrative Code. The current text of rule 901a 5 references section 103.2, 103.4, 106.5.1 to 106.5.3, 107.2.5, 107.2.5.3, and 109.2 to 109.7. None of that text 6 7 appears in the proposed rules to as remain or to be struck. The proposed text also adds Section 103.1 to the text, but 8 does not bold the reference in which it would indicate the 9 10 section was listed within the current rule. It is not.

It is proposed to strike Section 104.8 and 12 104.8.1. We request a reasoning to why the Bureau would be 13 removing protections for the code official from the health 14 code language. The code language that pertains to annual 15 permits, 106.1.1 and 106.1.2 should be retained or simply 16 modified to match the current language that is in the 2015 17 Michigan Code language.

18 Rule 905a, definition for action, not be written 19 into the code language. There are references within the 20 established rules and those draft rules that reference 21 different public acts of Michigan, such as the Skilled 22 Trades Regulation Act, the Occupational Code, the Adult 23 Foster Care licensing Act, as well as the 24 Stille-DeRossett-Hale Single State Construction Act. Where 25 any of the acts referenced within code language, it is, and



1 properly so, identified using its full name. 2 Public Act 230. I mentioned its name. The 3 Single -- the Stille-DeRossett-Hale Single State Construction Act within the act. It does not need to be 4 5 redefined in code language, which is subordinate to the act. Cold weather months should not be added to the definition. 6 7 The language used here should instead be added to the code 8 section that's intended to be modified, that being 309.1. 9 The definition of "Occupidal Space," which is --10 should not be changed within the mechanical code. The term 11 is used throughout the codes with a common definition. 12 Changing the definition here could confuse the requirements from other model codes for application to the spaces 13 14 mentioned. An alternative for redefining "occupidal space," 15 the desired exceptions to it should be identified in 309.1, 16 which is the section you intend to modify of the Mechanical

18 Rule 906a, the proposed changes, the proposed 19 changes to Section 106.3.1 should be renumbered to occur 20 within the section applicable to construction documents in 21 the model code, that being Section 107. As it stands, the 22 drafting of the --
